<p>Applicants must:</p> <ul style="list-style-type: none"> <li>• Be able to provide complete details of their employment history</li> <li>• Have evidence that their career progression is consistent with their personal circumstances</li> <li>• Have evidence that their present level of achievement and performance is commensurate with the totality of their period of training</li> <li>• <b>At least 12 months' experience<sup>vi</sup> (not including Foundation modules)</b> in an approved training scheme or equivalent by time of commencement of ST2 training</li> <li>• Must have demonstrated satisfactory progress towards the achievement of ST1 competences at the time of application and have achieved ST1 competences (as defined by the Clinical Radiology eCurriculum) by the time of commencement of the ST2 training post, supported by evidence from work place based assessments of clinical performance (Rad-DOPs, Mini-IPX) and Multi Source Feedback or equivalent, ARCP or equivalent</li> <li>• Have notified the Training Programme Director of the Specialty Training Programme they are currently training in if applying to continue training in the same specialty in another region<sup>vii</sup>.</li> <li>• Not already hold, nor be eligible to hold, a CCT/CESR in the specialty they are applying for and/or must not currently be eligible for the specialist register for the specialty to which they are applying</li> <li>• Applicants must not have previously relinquished or been released / removed from a training programme in this specialty, except if they have received an ARCP outcome 1 or under exceptional circumstances<sup>viii</sup></li> </ul>	<p>Application form Interview/selection centre</p>

- ii The GMC introduced the licence to practise in 2009. Any doctor wishing to practise in the UK after this date must be both registered with and hold a licence to practise from the GMC at time of appointment.
  - iii 'Intended start date' refers to the date at which the post commences, not (necessarily) the time an offer is accepted.
  - iv 'Selection centre' refers to a process, not a place. It involves a number of selection activities which may be delivered within the unit of application.
  - v Applicants are advised to visit the GMC website which gives details of evidence accepted for registration.
  - vi Any time periods specified in this person specification refer to full-time-equivalent.
  - vii The Support for Application to another region form, signed by the Training Programme Director of their current Specialty Training Programme confirming satisfactory progress must be submitted to the recruitment office at time of application.
  - viii Exceptional circumstances may be defined as a demonstrated change in circumstances, which can be shown on the ability to train at that time and may include severe personal illness or family caring responsibility incompatible with continuing to train. Applicants will only be considered if they provide a 'support for reapplication to a specialty training programme' form signed by both the Training Programme Director / Head of School and the Postgraduate Dean in the LETB / Deanery that the training took place. No other evidence will be accepted.
