<p><b>Qualifications:</b></p> <p>Applicants must have:</p> <ul style="list-style-type: none"> <li>• MBBS or equivalent medical qualification <b>or</b></li> <li>• First degree (1<sup>st</sup> or 2:1 or equivalent grade)<sup>ii</sup> <b>or</b></li> <li>• Higher certificated degree (Masters or PhD)</li> </ul>	Application form
<p><b>Eligibility:</b></p> <p>Applicants must:</p> <ul style="list-style-type: none"> <li>• Be eligible to work in the UK</li> </ul> <p><b>For those with a medical degree applying for a medical training post in Public Health</b></p> <ul style="list-style-type: none"> <li>• Be eligible for full registration with, and hold a current licence to practise<sup>iii</sup> from, the GMC at intended start date<sup>iv</sup> <b>and</b></li> <li>• Minimum of 2 years of postgraduate medical experience by time of appointment<sup>v</sup> (equivalent to that obtained in a UK Foundation Training Programme)</li> <li>• Have evidence of achievement of foundation competences, in the three and a half years preceding the advertised post start date for the round of application, via one of the following methods: <ul style="list-style-type: none"> <li>➢ Current employment in a UKFPO-affiliated foundation programme; <b>or</b></li> <li>➢ Having been awarded an FPCC (or FACD 5.2) from a UK affiliated foundation programme within the 3.5 years preceding the advertised post start date; <b>or</b></li> <li>➢ 12 months medical experience after full GMC registration (or equivalent post licensing experience), and evidence to commence specialty training in the form of a <i>Certificate of Readiness to Enter Specialty Training</i></li> </ul> </li> </ul> <p><b>For those without a medical degree, or those with a medical degree, choosing to apply through the non medical route</b></p> <p>At least 48 months (wte) work experience by application closing date, of which at least 24 months (wte) must be in an area relevant to population health practice<sup>vi</sup>. <sup>iii</sup> The GMC introduced the licence to practise in 2009. Any doctor wishing to practise in the UK after this date must be both registered with and hold a licence to practise from the GMC at time of appointment.

<sup>iv</sup> 'Intended start date' refers to the date at which the post commences, not (necessarily) the time an offer is accepted.

<sup>v</sup> 'Time of appointment' refers to the date at which the post commences, not (necessarily) the time an offer is accepted. For 2020 ST1 posts this will normally be **5 August 2020**, unless a different start date is specifically indicated in advance by the employing trust/LETB.

<sup>vi</sup> Experience relevant to public health practice will be evidenced either by registration through the health and care professions council or by explanation of relevance on the application form.

<sup>x</sup> The 'support for application to another region' form, signed by the Training Programme Director of their current specialty training programme confirming satisfactory progress must be submitted to the recruitment office at time of application.

<sup>xi</sup> Exceptional circumstances may be defined as a demonstrated change in circumstances, which can be shown on the ability to train at that time and may include severe personal illness or family caring responsibility incompatible with continuing to train. Applicants will only be considered if they provide a 'support for reapplication to a specialty training programme' form signed by both the Training Programme Director / Head of School and the Postgraduate Dean in the LETB / Deanery that the training took place. No other evidence will be accepted.
