<p><b>Eligibility:</b></p> <p>Applicants must:</p> <ul style="list-style-type: none"> <li>• Be eligible for full registration with, and hold a current licence to practise<sup>v</sup> from, the GMC at the advertised post start date<sup>vi</sup></li> <li>• Have evidence of achievement of foundation competences from a UKFPO-affiliated foundation programme or equivalent, by time of application in line with GMC standards/Good Medical Practice</li> <li>• Have evidence of competence via <b>one</b> of the following methods, for the round of application, as defined by the relevant curriculum: <ul style="list-style-type: none"> <li>➤ Current employment in a UK core medical training or ACCS (Acute Medicine) programme, or JRCPTB internationally level 3 accredited equivalent core medical training<sup>vii</sup>, and on track to successfully complete the training programme by the advertised post start date, <b>or</b></li> <li>➤ Successful completion, by no earlier than 1 January 2015, of a UK core medical training or ACCS (Acute Medicine) programme<sup>viii</sup>, or JRCPTB internationally level 3 accredited equivalent core medical training, evidenced by ARCP, <b>or</b></li> <li>➤ Evidence of achievement of core medicine competences at time of application.
